## **In-Home Caregiver Agencies**

In-Home Caregiver agencies provide caregivers who care for and supervise older and dependent adults within their own homes. Some of the services provided by in home caregiving agencies include: routine household chores, shopping, personal care, medication reminders, walking assistance, food preparation, social stimulation, and companionship. The objective of in-home assistance is to help the client to sustain independent living in a clean, safe and healthy home environment.

### **Definitions for Home Care Companies**

#### **Employee of the Agency**

The caregiver is employed by the agency. The agency takes taxes from their paychecks and reports earnings to the government.

#### **Independent Contractor**

The caregiver is NOT employed by the agency. The employer is the family who hires the caregiver. The independent contractor is responsible for paying their own taxes. The family is responsible for reporting to the government any payments made that exceed \$600 per year.

#### **Workers Compensation Insurance**

Insurance that covers the caregiver in case they are injured on the job. When the caregiver is an employee of the agency, the agency pays for this insurance. When the caregiver is an independent contractor, the agency does not cover them for injury on the job. The family, who is the employer, may be held liable in such cases.

#### **Liability Insurance**

Insurance that covers the caregiver for any malfeasance or wrong doing they may commit while on the job. All companies listed stated they have liability insurance that covers the caregiver, whether or not they are an employee or an independent contractor. This is important to verify.

#### **Licensing Status**

The In Home Caregiver agency has been licensed by the State of California Department of Social Services in accordance with provisions of the California Health and Safety code to operate and maintain a Home Care Organization.
