GOAL 1: SCAC will act in its advisory role to the OC Board of Supervisors (OCBOS).

- Objective 1: By May 11, 2021, SCAC will provide to the OCBOS the top 5
 priorities for services, facilities, programs, and funding to serve the needs of
 OC Senior Citizens. SCAC will take into consideration County, State, and
 National projections in providing the top 5 priorities for the next 2 to 5 years.
- Objective 2: On a regular basis, the SCAC Chair will provide to the OCBOS an update of the SCAC activities, senior trends, and areas of discussion.

GOAL 2: SCAC members will be advocates on senior issues identified and presented at monthly SCAC General Meetings.

- Objective 1: SCAC members will have contact with the Senior Center that they are liaison to, at a minimum, once a month. SCAC members will distribute SCAC meeting invitations and other information from SCAC to the Senior Center, the City, and Senior Organizations within their community.
- Objective 2: SCAC members will bring to the Executive Board and Standing Committees items of interest and concern to OC Older Adults.
- Objective 3: The Legislative Committee will track the progress of the CA Master Plan on Aging.
- Objective 4: SCAC Standing Committee Chairs will collaborate on Legislative items for tracking and status update.

GOAL 3: SCAC will seek representation by Senior Issues stakeholders in its membership and invited guests.

- Objective 1: On an ongoing basis, SCAC Executive Board will identify stakeholders who serve the varied interests of the Senior community and determine issuance of invitation.
- Objective 2: Semi-annually, the SCAC Chair will contact the OC Supervisors regarding SCAC vacancies within their District.
