## ABOUT THE ORANGE COUNTY VETERANS SERVICE OFFICE (OCVSO)

### **Our Mission:**

OCVSO actively pursues the rights of Veterans of the United States Armed Forces, and their dependents and survivors, to receive U.S. Dept. of Veterans Affairs (VA) benefits. The OCVSO works collaboratively with the VA, nationally chartered veteran organizations, and others to assure that Veterans, their dependents, and/or survivors receive entitlements earned while serving in this country's military services.

## Our History:

The County of Orange established the veteran's service program in 1929. On August 17, 1945, it was established as an independent program known as the Orange County Veterans Service Office.



# **VETERANS CLAIMS REPRESENTATIVES (VCRs)**


- Responsible for understanding laws and regulations pertaining to Veterans' benefits



# FEDERAL BENEFITS: SERVICE-CONNECTED DISABILITY

**Service-Connected Disability** includes monetary compensation for injuries incurred or aggravated in service, "secondary" conditions, "presumptive" conditions, and medical malpractice by the VA.

- Service-connected disability is a "key" that opens many other benefits.
- Service-connected Veterans with long-standing disability may want to apply for re-evaluation. OCVSO can help with this.





# FEDERAL BENEFITS: MEDICAL CARE & BURIAL BENEFITS

**Medical Care:** Most honorably discharged Veterans are eligible, with priority determined by the VA Medical Center.

- Higher priority Veterans are more likely to receive medical care.
- Low-income Veterans may qualify for co-pays waiver.
- OCVSO can help apply for medical care.

**Burial Benefits:** Most honorably discharged Veterans can be buried in a national cemetery free of charge.

- Monetary reimbursement is available for some Veterans receiving VA benefits or who died of a service-connected disability.
- Honorably Discharged Veterans are also eligible for a free headstone and burial flag.





## FEDERAL BENEFITS: PENSION

**Pension** is needs-based for Veterans who are unemployable due to disability or over age 65.

- Low income
- Wartime service
- Minimum length of service requirements
- Veterans may be eligible for a higher amount if housebound or requiring Aid and Attendance





## **AID AND ATTENDANCE**

"Aid and Attendance" is a type of needs-based pension payable to certain Veterans and their surviving spouses. It is also known as:

- Non-Service-Connected Pension for living Veterans
- **Death Pension** for surviving spouses of Veterans





## **VA NON-SERVICE-CONNECTED PENSION**

Low-income war era Veterans are eligible for this benefit if they meet these basic requirements:

- Must have low countable income (generally below the VA's)
- Maximum Annual Pension Rate and net worth below \$155,356
- Income-Based dollar for dollar benefit
- Minimum time served on active duty





## **SURVIVOR'S BENEFITS**

- Dependency and Indemnity Compensation (DIC)
- Survivor's Pension (formerly Death Pension for Surviving Spouses)
- California Veterans Home





## **DIC FOR SURVIVING SPOUSES**

### Dependency Requirements:

- Marriage: Married to the Veteran for at least one year immediately prior to Veteran's death <u>OR</u> had a child with the Veteran
- Continuous Cohabitation: Lived with the Veteran from marriage until the Veteran's death
- Has not remarried, with some exceptions

## **SURVIVORS PENSION**

Survivors Pension (formerly Death Pension for Surviving Spouses):

- Veteran had an honorable discharge
- Veteran had wartime service
- Veteran met the length of service requirements
- Surviving spouse meets income requirements
- Surviving spouse meets dependency requirements
- Surviving spouse does not need to be disabled or over the age of 65





## SURIVORS PENSION – HOW DOES IT WORK?

### Three levels of pension:

- Basic
- Housebound
- Aid and Attendance

With each level, your total income is subtracted from the maximum allowable rate, and VA pays the difference.

**<u>Unreimbursed</u>** medical expenses are subtracted from income.





# SURVIVORS PENSION EXAMPLE (MORE OR LESS)

- Ann is the widow of a deceased Veteran.
- Ann receives \$400 per month from Social Security.
- Ann pays \$100 per month for private insurance.
- Ann's countable monthly income is \$300.
- Ann's Maximum Allowable Pension Rate is \$624 per month.
- Ann's benefit is:
  - \$624 (maximum pension) <u>- \$300</u> (countable income)
  - = \$324 (monthly benefit)





## **VA HEALTHCARE**

- Primary access is through Compensation or Pension claims
  adjudication
- New Veterans who served in a combat zone have five years free medical
- Allows few veterans in with very high income


