

OC Cares: Master Plan for Aging

From the Desk of Michelle Aguirre, County Executive Officer

It is with immense pride and a profound sense of purpose that I present the OC Cares: Master Plan for Aging (OC MPA). This comprehensive five-year plan is a testament to our collective commitment to ensuring that Orange County (OC) remains a vibrant, healthy, and fulfilling place for all residents to live, work, and thrive, especially as they age.

OC is experiencing a significant demographic shift; by 2049, our population aged 65 and above is projected to increase by 66%, and projected to reach 36% of our total population by 2060. This growth underscores the urgent need for proactive, integrated strategies to support our older adults and their caregivers.

Developed through the collaboration and input from County or Orange (County) staff and advisory committees committed to serving older adults, and significantly informed by the OC Older Adult Needs Assessment surveys, the OC MPA is deeply rooted in the voices and experiences of our community. It aligns with the efforts of *California's Master Plan for Aging* (CA MPA) and its Five Bold Goals: Housing for all Ages & Stages; Health Reimagined; Inclusion & Equity, Not Isolation; Caregiving that Works and Affordable Aging.

Our plan outlines three priority initiatives, designed to drive meaningful, sustainable change at the local level:

- Housing Security: Our goal is to ensure housing security with a focus on supporting older adults to age in place. This includes increasing access to affordable, supportive, and accessible housing options, addressing financial instability, and exploring innovative housing models. We are committed to leveraging existing County investments and fostering new partnerships to meet this critical need.
- Public Information & Resource Campaign: We aim to create a comprehensive, accessible public information and resource campaign for older adults and their caregivers. This initiative will expand awareness and connection to vital programs and services aligned with the State's Five Bold Goals, utilizing platforms like OC Navigator and enhancing community resource fairs across all supervisorial districts throughout the County.
- 3 Enhanced Care Coordination: This initiative focuses on connecting vulnerable older adults to resources through a whole-person care approach. By implementing a data integration program and expanding the use of existing platforms like Compass OC, we will enhance care coordination, reduce barriers to accessing services (such as transportation), and ensure efficient, tailored support for our aging population.

The County Executive Office (CEO) will lead implementation of the OC MPA, ensuring coordination, progress monitoring, and sustained funding through our Strategic Financial Plan. This plan is more than a County initiative; it is a community-wide call to action, emphasizing the power of ongoing collaboration among public agencies, nonprofit partners, the private sector and the community at large.

Together, we will build a resilient OC where every older adult can age with dignity, security and vitality.


Orange County At-A-Glance

The County serves as a regional service provider and planning agency, delivering a broad spectrum of public and human services to more than 3.1 million residents. OC spans 798 square miles and includes 34 cities, several large unincorporated areas, nine beaches and 42 miles of coastline. OC has a high ratio of population per land area which made it the third most populous county in California (CA) as of 2021 and home to 8% of the State's population. Located in Southern CA, OC has a desired climate and easy access to parks and beaches, providing residents with opportunities for outdoor activities and community engagement.

Older Adult Population


According to 2023 US Census estimates, adults aged 65 and above make up 17% of the total population. In this age group, 30% report disabilities.* Rates of disabilities are highest among those 75 years and above, which is 45%.

Among all age groups, 65 years and older is the only age group with a projected increase in population as calculated by the CA Department of Finance. Specifically, there will be a 66% increase by 2049 as shown in the figure to the right. Furthermore, according to the CA Department of Aging MPA Dashboard, by 2060, this age group is projected to be 36% of the total OC population which will outpace the overall projection of 33% for this age group within the State.

Women comprise 54% of the OC population of 60 years and older, which is similar to CA (55%). While more than half identify as White (Non-Hispanic), OC has a diverse older adult population that will continue to diversify with individuals identifying with all other race and ethnicity categories.

Introduction

The County acknowledges the role older adults have in impacting the culture, economy, and daily lives of all residents in their communities through sharing their life experiences and knowledge. As OC prepares for the significant growth of the aging population, the County remains committed to addressing the evolving needs of older adults and caregivers. Adults 65 years and older are the fastest growing segment of the overall OC population. Although the commonly recognized age in the United States for a senior citizen is 65 years and older, this plan includes services for older adults who are 60 years and older. To address the growing needs for these individuals and ensure a healthy and supportive environment, the County has aligned its initiatives with the goals and strategies outlined in the CA MPA.

Statewide Context

In June 2019, CA released Executive Order N-14-19 which called for the creation of a statewide Master Plan to ensure the priority of health and well-being of older Californians and recognized the need for policies that promote heathy aging for this rapidly growing population. In 2021, the CA Department of Aging released the CA MPA which included strategies within the Five Bold Goals:

The County used these goals and their associated strategies to guide its efforts in development of its local plan which began with the execution of the OC Older Adult Needs Assessment that included three surveys to gather community voice: the Older Adult Community Survey, the Older Adult Paid Provider Survey and the Caregiver Survey. Findings can be found in the OC Older Adults Needs Assessment Report. In addition, other data sources and existing County services and programs were examined to identify service gaps that could be closed to address the concerns of older adults captured through the needs assessment. Through this data driven process, the County has also ensured that all Five Bold Goals were included in the development of the priority initiatives.

OC Imperative

In support of the commitment to the aging population within OC, the County is proud to introduce the OC MPA—a five-year plan which includes three priority initiatives designed to guide meaningful, sustainable change at the local level with the help of community partners. The OC MPA was developed to be both aspirational and actionable. It reflects the power of collaboration and reaffirms its commitment to promote and enhance service delivery and care coordination for the health, independence, and quality of life of older adults. The County is committed collaboration to ensure enhanced coordinated services for older adult needs. which includes a focus on cultural competency and accommodation for those with disabilities as older adults are among the highest rates within the total population. This plan envisions a more accessible, coordinated approach to serving older adults that will help to enhance the overall well-being of residents as they age.

The OC MPA is more than a County led initiative—it is a community-wide call to action. The well-being of OC older adult residents depends on ongoing collaboration among public agencies, nonprofit partners, the private sector and the community at large.

The community also supports this collaborative approach, as most of the respondents to the OC Older Adult Community Survey feel that the County's role is to "be an educator and/or facilitator" and "provide a safety net covering basic human needs". The preferred role for the County is to help coordinate and lead efforts as opposed to being "the lead in all aspects" highlighting the importance of this collaborative effort.

The OC Cares vision is to build a resilient community that supports the well-being of all its members, now and for generations to come.

The OC MPA envisions a future where all older adults and their caregivers thrive in a healthy, independent, and high-quality living environment. Through robust collaboration among County agencies, community organizations, and private partners, the County is committed to enhancing coordinated services that address the evolving needs of our diverse aging population. This plan focuses on ensuring housing security, expanding access to vital information and resources, and providing enhanced, whole-person care coordination, ultimately fostering an OC where residents can age with dignity, security, and vitality.

The County's priority initiatives align with CA's MPA's Five Bold Goals. The priority initiatives are supported by data sources which include the voices of the community captured through the OC Older Adults Needs Assessment.

In addition, priority initiatives were developed based on a gap analysis which included a comprehensive review of the County's programs and services specifically for older adults. This Inventory, detailing current County programs and services as of Spring 2025, was categorized according to the strategies identified within each of California's Five Bold Goals. The Older Adult County Programs and Services Inventory is included on page 28 of the appendix.

Each of the three priority initiatives include multiple state goals and presents valuable opportunities to enhance services, strengthen resources, and address the most pressing needs of older adults within OC. These priority initiatives are expected to evolve over time in response to stakeholder feedback and population considerations, including cultural competency practices, and other emerging needs and challenges.

County Investment for Implementation

The County's budget development begins with the Strategic Financial Plan (SFP), an annual strategic financial planning process that includes a five-year revenue and expense forecast as well as identification of strategic priorities and emerging initiatives. This framework enables the OC Board of Supervisors (BOS) to make annual funding decisions within the context of a comprehensive, long-term perspective. Existing strategic priorities for FY 2024-25 include OC CARES and Permanent Supportive Housing (PSH) & Affordable Housing. Through the development of the projects within the priority initiatives, these existing strategic priorities will be expanded to plan for funding and resources needed for implementation of the initiatives. This will also serve as the process for upcoming fiscal years if additional emerging projects within the priority initiatives are identified through the implementation process. See figure on the right for the County's Budget Planning and Development Cycle.



Additionally, the County received the Local Aging and Disability Action Plan (LADAP) Grant to fund the development process, which included the OC Needs Assessments. The County will ensure a continued focus on funding of these priority initiatives through the SFP process explained above. Over time this will help secure the long-term financial and resource commitment needed for completion of projects that will be planned by the Priority Initiative Action Teams for each of the initiatives. Prior strategic priorities will be expanded on to incorporate the three priority initiatives within the OC MPA as shown in the figure below. Additional details can be found in the 2024 Strategic Financial Plan or in the Citizens' Guide to 2024 Strategic Financial Plan.

Priority Initiative Implementation

The CEO will designate project leaders to serve as the primary liaison to the bodies that comprise the OC MPA Priority Initiative Action teams and the community. The CEO will ensure the development of projects within the priority initiatives which will include population considerations and maintain progress. The CEO Data Analytics Team will provide oversight in performance monitoring and reporting of all action items and progress indicators.

Priority Scope

The long-term intent of this initiative is to address housing and financial instability challenges for OC older adults. The County aims to do this by supporting housing resources which include:

Affordable Housing

Housing when housing cost is no more than 30% of an individual's income.

Supportive Housing

Combines housing with essential support services to help individuals achieve stability and improve overall well-being.

Accessible Housing

Housing that is designed and constructed to be readily accessible and usable.

Background & Supporting Data

Identified Need for Older Adult Accessible Housing

The American Association of Retired People (AARP), scored OC above average in their index for United States overall rating of livability for older adults regardless of factors of income, ability level and background of senior residents. Although OC is rated high overall as an ideal place to live, this index includes a housing score that had some lower ratings. OC scored higher on ratings for housing on zero-step entrances and availability of multi-family homes and scored lower for housing costs, housing cost burden and availability of subsidized housing. These findings are consistent with the OC Older Adult Community Survey, where OC also scored high as an ideal place to retire, but not all city residents scored their city of residence favorably for availability of senior housing (e.g., availability of long-term options, availability of accessible housing, availability of day-time options, etc.) with discrepancies among the city ratings.

Identified Need for Housing Affordability

In OC, 72.2% of older adults live within owner-occupied households, more than one in four (27.8%) are renter-occupied according to the US Census 2020: DEC Demographic and Housing Characteristics. In the OC Older Adult Needs Assessment Report, becoming homeless was more of a concern for those who were renting a home or apartment and for older adults who were between the ages of 55 and 69, suggesting the highest concern for housing affordability for this renting group as they get older. According to the California Department of Aging Dashboard, in 2023 OC had lower subsidized housing rates (40.9) for older adults and those with disabilities compared to the state (48.9), indicating a need to increase affordable housing for this vulnerable population.

Resources & Potential Considerations

Housing Funding Strategy

On June 12 2018, the OC BOS accepted the Housing Funding Strategy which identified the need for affordable supportive housing units. The County has already committed more than \$100 million for permanent supportive and affordable housing since 2018 through this strategy. Additionally, in 2022, the Housing Funding Strategy Update highlighted older adults as a priority population and the OC Housing Authority Administrative Plan prioritized housing vouchers for older adults.

Community Partners & Key Stakeholders

The County commits to maintaining and expanding its network of partners. Development of this initiative may lead to the identification of vital outside County stakeholders, including cities, private industry partners (e.g., housing developers, etc.), and community partner agencies.

OC Housing Finance Trust (Trust)

This trust was formed in 2019 as a joint power's authority between OC cities and the County to fund housing, specifically assisting unhoused and/or low-income individuals within OC. While the County continues this effort, for the development of actual housing units, only some cities have contributed in the second year for administration. As of fiscal year 2024-2025, the County has been the sole Trust member to contribute funding for the Trust Notice of Funding Availability (NOFA) as reflected in the Trust thus far.

County Strategic Financial Plan

Housing efforts continue to be a priority as identified in the 2024 Strategic Financial Plan which plans for resources in the upcoming years (explained on page 10) toward these efforts. Capital fund development plans will help in this partnership.

Priority Scope

The long-term intent of this public information and resource campaign will be to address older adults and their caregiver's concerns around not knowing what type of programs and services related to health (i.e., mental, behavioral, and physical health prevention and treatment efforts), public safety (e.g., fraud and scam prevention, legal planning, abuse and neglect reporting, etc.), and inclusion (e.g., transportation accessibility, work and volunteer opportunities, fire safety and evacuation routes, etc.) are available to them. This priority will also enhance coordination and collaboration efforts amongst the County, OC's older adult service providers, community-based organizations, and outside stakeholders by promoting a more accessible way to access information in multiple languages, including print and digital media, for OC's older adults.

Background & Supporting Data

Identified Need for Older Adult Resources

Health

Overall, OC older adults have higher rates (79%) of good health compared to all older adults in California (75%) according to the California Department of Aging Dashboard. Although many older adults are in good health, most top-rated concerns for OC's older adults were health related conditions including Alzheimer's Disease and Dementia followed by arthritis and cancer as determined by the OC Older Adult Assessment findings. Ease of access to preventative and treatment health resources is important to help address these health concerns. While 8 out of 10 older adults reported they were comfortable navigating healthcare resources on their own, participants also reported challenges in accessing medical and behavioral health care in the past year because they "did not know where to get help". This suggests that streamlining and simplifying the process of finding health information and resources could improve healthcare access for older adults, especially for those aged 80 years old and above, since not all older adults reported being comfortable with using technology and the internet.

Public Safety and Inclusion

Although nearly one-third of OC older adult participants in the OC Older Adult Needs Assessment identified socialization groups as being an important service for older adults, there were discrepancies among the cities with favorable ratings for having public places for older adult residents to spend time and/or having employment opportunities. In addition, unemployment or lack of job opportunities contributed to 8.5% of participant's medical issues and 7.7% of participant's behavioral health issues. Even more so, heath issues were reported as being affected by fraud and scams, which was endorsed by 19% of the participants. These findings suggest the need for improving access for resources to older adults within different services, as these services affect many aspects of older adult lives.

Identified Need for Caregiver Resources

According to the California Department of Aging Dashboard, 13% of OC adults were providing care to a family or friend with a long-term illness or disability in 2023. Within the OC Caregiver Survey, caregivers unpaid friends or family members caring for an older adult who resided in OC - acknowledged the interest in more information regarding senior services and programs, health services and knowledge of local and community programs and services. In addition, for caregivers, it was evident that caregiving takes a negative emotional, financial and sometimes physical toll on those who provide care. Many revealed that balancing caregiving responsibilities and having time for oneself was challenging. This highlighted the potential benefits of accessing more adult day-care drop-in opportunities and how to find temporary inhome care, as well as self-care and wellness resources to increase caregivers' quality of life, options and capacity for caregiving. In addition, given their time restraints, it was not surprising that caregivers preferred online support over in-person support.

Resources & Potential Considerations

OC Cares

OC Cares is a countywide initiative addressing the needs of OC residents and accessibility to services and programs through the County's five Systems of Care: behavioral health, healthcare, housing, or benefits and support services and community corrections. This care includes coordinated care management, linkages to programs and services, and assistance with job readiness and employment.

OC Navigator

Since 2022, the County began the development of OC Navigator, a digital navigation tool that also offers print resources, to guide OC residents to resources that support their behavioral health and wellbeing. Core features include an optional wellness check-in survey, curated lists of resources across various categories of health and wellbeing, the ability to update resources in real-time and translation in the County's threshold languages.

Community Partners & Key Stakeholders

The County commits to maintaining and expanding its network of partners. Development of this initiative may lead to the identification of vital outside County stakeholders, contracted providers, community-based organizations including faith-based organizations, managed health care plans, private healthcare providers and other community stakeholders.

"To connect vulnerable older adults to resources with a whole person care approach."





Inclusion & Equity, Not Isolation



Priority Scope

Through this initiave, the County will leverage partnerships, both existing and new, to better connect older adults to resources with a whole person care approach which may include:

Resource Opportunities (e.g., housing, transportation, food assistance)

Health Care Resources

Public/Personal Safety Information (e.g., elder abuse and fraud prevention)

Job Placement Opportunities

Inclusion Opportunities (e.g., volunteer opportunities, older adult activities)

Legal Planning Resources

The long-term vision for enhanced care coordination uses data to ensure the effective and efficient connection of resources and opportunities to individuals. As a result of coordinating services such as scheduling multiple service appointments back-to-back, barriers related to transportation can be minimized or eliminated.

Background & Supporting Data

Identified Need to Provide Coordinated Services to Reduce Barriers for Older Adults

Although OC has a high ratio of available health care professionals for the population, accessing care and resources is not always easy for older adults. The OC Paid Provider Survey results revealed that slightly over half of paid providers felt services were moderately accessible because of the required effort and flexibility of older adults. Additionally, the OC Older Adult Community Survey results indicated that the following barriers prevented older adults from seeking medical services:

- Appointments not being available at convenient times (38%)
- High cost for copays (30%)

- Don't know where to get help (26%)
- Lack of transportation (19%)
- Locations being too far away (14%)

These barriers were also relevant to those who needed behavioral health services. In terms of transportation, community ratings among cities in ease of transportation ranged from 23% to 78%, with an average of 41%. Disparities among community ratings as well as demographics highlight the importance of tailoring efforts to connect individuals to appropriate services, support, and programs.

Resources & Potential Considerations

OC Cares

OC Cares is a countywide initiative addressing the needs of OC residents and accessibility to services and programs through the County's five Systems of Care: behavioral health, healthcare, housing, or benefits and support services and community corrections, and includes coordinated care management, linkages to programs and services, and assistance with job readiness and employment.

Strategic Priorities

Care Coordination has been identified as an Emerging Initiative and Strategic Priority in the 2016 to 2023 SFPs. The Priority initially addressed care coordination surrounding individuals experiencing or at risk of becoming homeless but was expanded to allow for better coordination of services and robust data and metrics reporting for additional populations. Replicating this structure, the County will use Compass OC, the County's internal data sharing platform, to enhance care coordination for older adults.

The Care Plus Program (CPP)

CPP offers enhanced care coordination for those who are the most vulnerable across the County's System of Care: Behavioral Health, Community Corrections, Healthcare, Housing, and Benefits and Supportive Services. The program objectives are to expedite the identification of client needs and provide subsequent linkages to services with greater collaboration and maximization of resources. The program is facilitated through the innovative data integration platform Compass OC and the use of multidisciplinary team meetings.

Compass OC

Enables data sharing between County departments and community-based organizations by pulling specific data elements from numerous County databases to create a holistic view of a client's program history and service utilization. Additionally, Compass OC facilitates the creation of Care Plans for clients, including referrals and linkages to services, to assist in care coordination and case management. Multidisciplinary teams, comprised of subject matter experts across the System of Care, meet on a regular basis to support and inform the development of Care Plans and coordinate approaches to overcome barriers to care for clients of the CPP.

Advisory Committees

The OC Older Adult Advisory Commission (OAAC), OC MPA Steering and Advisory Committee, Care Plus Program Steering Committee.

Healthcare Coordination

Health care coordination ensures that health care providers coordinate the physical, dental, behavioral and social services of their patients. Agencies must follow State and Federal regulations to ensure that their respective health plan members receive timely access to appropriate care, and within OC the Health Care Agency and managed care plans are working to ensure individuals with high-needs and receiving MediCal have coordinated access to clinical and social services.

Community Partners and Key Stakeholders

Development of this initiative may lead to the identification of vital outside County stakeholders, contracted providers, community-based organizations including existing contracted care coordinators, local partner agencies (i.e., OC Transportation Authority, Cal Optima, etc.) and other community stakeholders.

This commitment aims to cultivate an OC where its inhabitants can be supported through coordinated efforts so they can age with grace, security, and vigor. The plan envisions a future where older adults and their caregivers can continue to benefit from living in OC and flourish within a healthy, independent, and high-quality living environment.

Next Steps

The County will organize collaborative opportunities for subject matter experts, both internally and with outside stakeholder, to gather input on projects for all three of the priority initiatives. The CEO will oversee the implementation of the three initiatives within the OC MPA, responsible for coordinating activities, monitoring progress, and securing consistent funding through the OC SFP. The execution of the OC MPA is anticipated to lead to improved services, strengthened resources, and a more streamlined and integrated approach to assisting the aging population, ultimately elevating the well-being and life quality for OC's older adults and their caregivers.

Orange County Master Plan for Aging Development Background & Next Steps

Statewide Context

In June 2019, Governor Gavin Newsom issued an executive order mandating the creation of a statewide Master Plan for Aging (MPA). This order underscored the state's commitment to the health and well-being of older Californians and the necessity of policies that foster healthy aging. The State's MPA acknowledges the rapid growth of its older adult population, with projections indicating that adults aged 60 and above will increase from 16% in 2010 to 25% (10.8 million residents) by 2030.

Orange County's (OC) Demographic Imperative

OC faces an even more pronounced demographic shift for adults 65 years and older. By 2060, its aging population is projected to be 36% which will be higher than the projected state rate of 33%.

OC's Development Process

To address this growing need, the County initiated a robust development process for its MPA:

- **Strategic Alignment:** The development of OC MPA was fully aligned with the County's strategic priorities and its Strategic Financial Plan (SFP) for fiscal years 2021 and 2022 and the OC MPA priority initiatives will continue to align with current and ongoing SFP fiscal years and initiatives.
- Advisory Panel Formation: An MPA Steering Committee and Advisory Advisory Committee was
 established, comprising representatives from key County departments, including the Social Services
 Agency, County Executive Office, Orange County Community Resources/Office on Aging and Orange
 County Health Care Agency's Mental Health Recovery Services and Public Health Services programs.
- Authorization of Assessment: After a competitive request for proposal process, on January 11, 2023, the
 OC Board of Supervisors (BOS) approved a contract with AdvanceOC to conduct a comprehensive,
 countywide healthy aging assessment. This assessment was designed to identify and prioritize the specific
 needs and factors impacting the health of OC residents aged 60 and older.
- **Public Outreach and Communication:** A press release was issued on September 5, 2023, announcing the launch of the community surveys and detailing upcoming education and resource fairs across hosted by each of the OC BOS in their respective districts. The resource fairs were dynamic, on-the-ground events held in trusted local spaces where older adults already felt welcome. Each event was paired with a resource fair, connecting attendees to vital programs, services, and community partners. The MPA advisory panel, in collaboration with AdvanceOC, developed an internal communications plan and a media toolkit to provide messaging and graphic assets for social media, newsletters, and websites to assist Districts, Departments, and community-based organizations in promoting the surveys.
- Stakeholder Engagement: The County Executive Office and MPA Advisory Planning Committee launched a strategic planning and development phase, that included the creation of the administration of the OC Older Adult Needs Assessment Surveys. Through three surveys, the purpose of this assessment was to explore the experiences and perspectives of OC's older adults aged 55 years and older (to project OC residents 60 years and older needs), family and friend caregivers and paid service providers. The combination of these three perspectives provides valuable insights into what is going well within OC and areas for improvement. To stay true to our commitment to ensure every resident was represented, we provided Spanish and Vietnamese language access at the town halls. This was key to making sure older adults across OC regardless of language could fully engage, ask questions and receive the information they needed. Advance OC partnered with many different OC community-based organizations to assist in survey distribution and coordinated to ensure survey administration in hard-to-reach populations which included those who were incarcerated and unhoused.

The County Executive Office Data Analytics Team and the Health Care Agency's Behavioral Health Services Data Analytics and Evaluation Team led the data validation and analysis for all three surveys. In addition, the teams created the OC Older Adults Needs Assessment Report and website with detailed results for all questions within the surveys as well as subgroup findings for demographics. Following the release of the OC Older Adult Needs Assessment Report, the County conducted presentations, including an online presentation that was posted on the OC's Office on Aging website, and requested feedback at the end of all presentations. Presentations included the following:

- OC Older Adults Advisory Commission
- OC Behavioral Health Advisory Board
- Countywide Online Presentation

The full report, presentation materials including the full online presentation recording can be found on the Office on Aging Website.





County Programs & Services Inventory

The County provides many vital programs and services for the older adult population through different departments and offices. OC aging services network is essential in addressing the evolving needs of older adults and caregivers. This program and service inventory was developed in Spring of 2025 to align County programs and services to CA's Five Bold Goals.

County of Orange Departments

County Executive Office (CEO) - Office of Care Coordination (OCC)

Partners with cities and community-based organizations to strengthen regional capacity in preventing and addressing homelessness.

County of Orange Social Services Agency (SSA)

Administers social service programs that serve as a safety net ensuring families, older adults and individuals with disabilities have access to health care, food assistance and cash benefits to facilitate stability, self-sufficiency and independent living.

Orange County Child Support Services (CSS)

Guides families through the child support process, by providing personalized services that help ensure children receive financial support – regardless of the age of the individual, parent, or custodian.

Orange County Community Resources (OCCR):

- Office on Aging (OoA) is the County's designated Area Agency on Aging (AAA) and addresses the needs of older adults, caregivers, individuals with disabilities, veterans and the underemployed.
- Orange County Animal Care (OC Animal Care) promotes responsible pet ownership for the health and safety of people and their pets.
- Orange County Housing Authority (OCHA) administers federally funded programs to provide rental assistance to qualified tenants in privately owned rental housing.
- Orange County Housing & Community Development (OCHCD) administers the County's affordable housing development, community development, and housing successor agency programs.
- Orange County Parks (OC Parks) is committed to managing land and facilities in a way that maximizes
 their enjoyment by the public while properly maintaining and overseeing them, so they are available for
 generations to come.
- Orange County Public Libraries (OCPL) is rooted in promoting lifelong learning, fostering community connections, and ensuring free, open access to knowledge and tools that enrich lives.
- Veterans Service Office (VSO) provides advocacy services and assistance to OC Veterans, survivors, and dependents, focusing on U.S. Department of Veterans Affairs disability and survivor benefits.
- Workforce and Economic Development Division (WEDD) administers programs and activities of the Workforce Innovation and Opportunity Act (WIOA) in OC.

Orange County Health Care Agency (HCA)

Protects and promotes community health through services such as food safety, ocean water monitoring, mental health support and substance abuse treatment.

Orange County Sheriff's Department (OCSD)

Provides exemplary law enforcement services through a collaborative, dedicated and innovative approach to public safety.

Scatter Site

Emergency shelter sites throughout a community, rather than in a single, congregate facility.

Service Planning Area (SPA)

SPAs are geographically defined regions used to organize and coordinate homeless services. These SPAs help to tailor resources and interventions to the specific needs of individuals experiencing homelessness within that area. OC is divided into three SPAs: North, Central and South.
