2026-2027 Goals and Objectives

In support of the Orange County Master Plan on Aging (OC MPA) Priority Initiatives, the Older Adults Advisory Commission (OAAC) is establishing specific tasks to support the three priority initiatives:

1. Housing Security
2. Public Information and Resource Campaign
3. Enhanced Care Coordination

Goal 1: Information Access

- ***Promote community services for older adults and caregivers to boost awareness and access.***
 - a. Collaborate with the Office on Aging (OoA) to distribute readily available information on County, State, Federal, and non-profit services that enhance older adult's lives.
 - b. Promote OoA's Monthly Newsletter:
 - i. Launch a campaign to expand email subscriptions toward reaching older adults.
 - ii. Improve newsletter content by gathering and submitting updates from senior centers, libraries, and community events to the OoA to increase usability.
 - iii. Expand outreach to older adults via collaborations with senior centers, faith-based groups, libraries, healthcare partners, and public sector agencies and utilities.
 - iv. Support ongoing social media promotion and campaigns that highlight available programs and services.

Goal 2: Aging in Place

- ***Promote resources that support older adults to age safely and independently at home.***
 - a. Assist the County in developing a coordinated home-sharing program that matches older adults' homeowners with available spare rooms with individuals in need of affordable accommodations:
 - i. Planning: Research national best practices and engage stakeholders to design program guidelines, including rigorous background screening and matching criteria.
 - ii. Implementation: Support the process of securing sustainable funding and launching targeted outreach to help identify potential participants.
 - iii. Operations: Advocate for the future development of standardized agreements that clearly define household responsibilities and provide a formal process for dispute resolution.
 - b. Compile and promote resources for financial assistance and caregivers supporting older adults.
 - c. Participate in RFP evaluation panels for aging service contracts administered by the County to provide subject matter expert input.

To accomplish our Goals OAAC recommends the following:

- Form an Ad Hoc committee to determine OAAC's Key Performance Indicators (KPIs), metrics, and success criteria.
- Form an Ad Hoc committee to explore Home Share options.
- Participate in RFP evaluation panels for aging services.
- Participate in the OC MPA Action Teams that support the MPA Initiatives.
